Wollongong City Council Liaison Meeting

Bulli Extensions and Refurbishment

The handover is planned for 13 September 2017.

The club has an onus to finalise the refurbishment of upstairs, therefore the Council will complete an Interim Occupation Certificate which will allow the club to operate downstairs and that once the upstairs refurbishment has been completed, and suitable to pass certification, a full Occupation Certificate will be granted.

The car park resurfacing is well underway. There are still some minor issues to sort of with the club and Council.

Austinmer Shared Facilities

This project is to be considered by the new incoming Council. The DA is complete and ready to be submitted to Council once they are duly elected and sworn in.

North Wollongong

The DA drawings have been completed and needs sign off by a Quantity Surveyor under the seal of the new Council as per the Austinmer project.

Scarborough

Council have found some issues with this project as the land is not Crown or Council owned and controlled. It is owned by a mining company. They are attempting to sort this out and possibly purchase this land.

A maintenance report has been submitted on plumbing requirements but to date this work has not yet been programmed.

Bellambi

The DA has been approved and work will commence in May 2018.

Fairy Meadow

The roof has been removed by Council's contractors. This work seems to have occurred out of the maintenance schedule and the club may need to utilise shipping containers this summer till the work has been completed. The club was caught unaware that the work would commence and this will affect activities this summer.

Dune Maintenance

Work will commence at Port Kembla and Wollongong this week. This will be interim work and the main dune movement and reshaping will occur in May 2018.

Hours of Patrol - Sandon Point

There will be no changes to hours of patrol. It is the desire of Council to align patrol hour obligations to the SLS NSW requirements.

Coast Safe Report

Council are investigating listing East Corrimal and Puckeys under the Black Spot grants with the SLS NSW.

Licencing

Council have had complaints regarding non-approved use of surf club buildings.

Clubs are reminded that activities such as hall hire which are controlled by the clubs themselves are acceptable. However, those clubs who authorise any external contractor other than the club, eg: commercial operations, must submit a DA for this as an approved usage.

There is a DA process and this must be entered by any club who considers allowing a contractor to utilize its buildings other than the club itself.

Council stressed that this requirement is not about clubs hiring its halls for a function, it is about clubs out sourcing its amenities to a commercial operator who uses that club house facility.

The Council advised that they are not against this outsourcing, but that a DA consent must be approved as an altered use of the buildings.

Season Start

Friday 22nd September 2017 at North Wollongong Beach at 10 am is the official Council beach opening day. On Saturday, the 23rd September 2017 the flags go up for the summer.

Shark Spotting

Council have signed a contract with Touch Down Helicopters in partnership with DPI.

They will be spotting on Sundays.

Clubs are reminded that if any positive ID is made of a shark that the club is to contact the Lifeguard Supervisor on that day.

A helicopter and jet ski will be dispatched to assess the situation.

Council are investigating trialling shark deterrent devices that emit a radio wave to deter shark presence.

Trainee Lifeguard Program

Council are willing to set up a trial of this program.

This will be on Saturdays only and may lead to young lifeguards gaining casual work with Council when they seek recruits. For our clubs as a way to satisfy the requirements of Saturday patrols.

Discussions are still occurring on how this will work.

It will however be open to all clubs.

Minimum requirements need to be set, ie Bronze and ARTC as well as a skill test comparable with a Cert II.

The issuing of a new award (workplace) is being investigated.

It may also include Council operated swimming pools.

The Trainee Lifeguard Program is seen as a retention mechanism for clubs and a provider of suitable young lifeguards by the Council.
