SLSA is looking for capable and experienced officials to fill positions in each of the sections/areas. Please ensure you only choose three positions when selecting your preferences.

If you are nominating for a Senior Technical Official position, please ensure you also submit your preference for a Technical Official position in case you are unsuccessful in gaining a Senior Technical position.



After the appointment of the Championship Referee and Deputy Referee, the appointments of all Officials will be made jointly by the National Chair of Sport and the National Officials Advisor. Officials will be finalised as soon as possible after the close of nominations and all appointments will be posted on the [Interstates webpage](#) and [Members Area](#).

Late nominating Officials will be added to the 'Officials Pool', and duties and appointments will be made subject to availability of roles.

All officials should ensure that they are physically able to carry out their appointed role at Interstates 2018, and are encouraged to undertake a medical check prior to departure for the event.

NOTE 1: All appointed Officials will be required to attend the **OFFICIALS BRIEFING** as well as a briefing in their appointed competition areas, prior to competition. All times and locations will be outlined in the 'Officials Appointment Circular' distributed at a later date.

NOTE 2: For this Championships, a limited number of officials will be appointed, officials who were unsuccessful in their appointment will be added to the 'Officials Pool' If a position becomes available an official will be contacted to ascertain their availability. We apologise for any inconvenience with regards to this process.

As part of the Interstates 2018 safety procedures, the safety and contingency plans will be communicated in detail. Therefore, the Officials Briefing is mandatory and failure to attend may result in your appointment being terminated and or referred to the Interstates Championships Competition Committee and Safety & Emergency Committee for further action.
