Summary:	Call for officials nominations for the 2018 National & Interstate IRB Championships that will be held at Thirroul Beach from July 12 th – 15 th 2018.

SLSA is now calling for nominations from all currently licensed SLSA Surf Sports Officials (Level 1 minimum) wishing to participate and further develop their skills at the 2018 IRB Championships to be held at Thirroul Beach. The Championship will be held over three days 13th, 14th and 15th of July 2018.

The appointment of all Officials will be made jointly by the Championship Referee and Surf Life Saving Australia's National Officials Advisor. Officials will be finalised as soon as possible after the close of nomination and all appointments will be posted on the members Portal and 'event info' section of the National IRB Championships webpage. Late nominating Officials will be added to the 'Officials Pool' and duties and appointments made subject to availability of roles.

All officials should ensure they are physically capable to carry out their important functions over the course of the Championships, and are encouraged to undertake a medical check prior to departure to the Championships.

NOTE: Nominees must indicate if they are available for Scrutineering on Thursday 12th July

NOTE: All appointed officials should be able to officiate the **full three days** including until the completion of competition on the Sunday.

NOTE: All appointed officials will be required to attend the officials briefing, prior to competition. All times and location will be outlined in the Officials Appointment Circular distributed at a later date.

NOTE: SLSA will be appointing only the required number of officials.

As part of the 2018 National and Interstate IRB Championships safety procedures, the safety and contingency plans will be communicated in detail. Therefore, the Officials briefing is mandatory and failure to attend may result in your appointment being terminated.
