#### Lifesaving:

- We have unfortunately had two drownings over the Christmas period both of these drownings occurred outside patrolled areas, one at Sharky's and the other one at MM Beach. I would like to thank Duty officers and Patrol support persons that assisted in dealing with these two incidents.
- We've also had several incidences that has prompted me to put out a general warning again about the use of powercraft and our powercraft code of conduct. Three separate incidents, one with an ATV one with an IRB and one with an RWC. We must all be mindful of our highly visible craft and responsibility to public safety.
- On a better note I would like to thank the operators that helped out in last weekend emergency call
  out regarding the bushfire evacuation from the National Park, Surf life saving Illawarra managed to
  send four support skis to assist.
- After investigating and number of Patrol defaults I have two warning letters to send out and waiting for further information on another.
- Some discussion needs to be entered with Port Kembla regarding their Saturday patrols.
